



2022 Public Safety Officer Career Advancement Grant (PSOCAG) Program Application

PSOCAG is a state-funded grant program offered for up to tuition and fees (maximum of \$5,000 per year, subject to funding) for students enrolled in criminal justice-related programs at Weber State University available for up to four academic years. Any reimbursements received under the previous PSOCAR program will count toward the overall limit of four academic years. If total qualified applicant awards exceed available funding in any given year, awards will be reduced on a pro rata basis across all qualified applicants.

- Qualified PSOCAG applicants may submit applications beginning July 1, 2022.
- **The priority deadline for 2022 PSOCAG applications is December 1, 2022.**

Qualified PSOCAG applicants must:

- be a certified peace officer, currently employed by a law enforcement agency in Utah;
- be seeking a post-secondary degree in a criminal justice related program from a credit-granting USHE Institution;
- maintain Satisfactory Academic Progress each semester;
- submit a FAFSA (Free Application for Federal Student Aid) annually;
- submit employer certification from an authorized representative at a Utah law enforcement agency;
- submit official transcripts from any other post secondary institutions attended (if applicable);

Submit completed applications to finaid@weber.edu with the following information:

1. Complete all required fields
2. Sign and date the application
3. Attach transcripts for any post secondary institutions attended (if applicable)
4. Attach letter of employment verification from eligible Utah Law Enforcement Agency on letterhead with signature from authorized representative
