Staffing changes proposal

- ➤ WSU Charter currently has low enrollment numbers (10 students in the AM & 6 students in the PM)
- Low enrollment overstaffing
 - The proposal is to layoff the full-time assistant position. Requiring laying off the current paraprofessional in that position. (PPM3-10b)
 - Note: This position is funded through the School LAND Trust. The WSUCA Board of Directors will work
 with the WSUCA School LAND Trust council on a plan to amend the current plan and re-allocate those
 monies.
 - Process BOD Vote
 - WSU HR AA/EO and Provost support
 - It was asked when the layoff would take place? It will be the process of WSU HR.
 - Camie asked what the layoff looked like, since they were calling it a layoff. Could they staff return when the school reopened? The answer was no, they would have to reapply.
- Angela motions for the proposal to eliminate the full-time position which will mean the layoff the full-time paraprofessional. Wei seconds. Passed unanimously.

Future of program proposal

- > Future of program planning to meet needs
- ➤ Low enrollment need more than half-day kindergarten
- Renovation of Mckay Ed Building losing space
 - Proposal is to pause in operations for 2 years until space is available in the newly renovated ED building (expected Fall 2025). The Board of Directors will do market research and update the Charter Agreement with WSU as the authorizing entity.
 - VSIP DUE date
 - Staffing Decisions will be made in consultation with MCOE, Dean Kristin Hadley and WSU Human Resources, Meagan Thunnel.

- Early retirement due date is this Friday, Oct 7, 2022, which could be applied for by Letitia and possibly for Lorraine. Kristin said that HR contacted her and said that because the Para's position is being eliminated, Lorraine would not qualify for early retirement.
