## Cohort Default Rate

The national student loan “cohort default rate” (CDR) measures the percentage of federal student loan borrowers who default after entering repayment. The 2020 rate for Weber State University, reflecting students in default from 2018-2021, is 4.1%, below both the national average of 7.3% and the public institution average of 7.0%.
